PLEASE NOTE: SCH TEN CATS HAS ONE COPY OF HERDA, HE IS ONLY AVAILABLE TO MARES THAT ARE TESTED CLEAR.

1. SERVICE FEE

The Service Fee is non-refundable and payable in full upon return of the signed breeding contract. The mare or another suitable mare is entitled to a Free Return the following season if the mare fails to have a PPT at 45 days, the foal dies within forty-eight (48) hours of foaling or if the foal is stillborn, in all circumstances a report certified by a Veterinary Surgeon is required.

This contract shall NOT be assigned or transferred by the Mare Owner without the written consent of the Stallion Owner.

2. VETERINARY

All Veterinary expenses incurred for the mare and or progeny, including pregnancy tests, will be paid by the Mare Owner. The Mare Owner warrants that to their knowledge, the mare is in good health, up to date with vaccinations and worming and has NOT been in contact with STRANGLES, HENDRA or any other infectious disease. The Stallion Owner/Agent at any time and at the expense of the Mare Owner can have the mare examined for such infectious diseases for any purpose what so ever by a Veterinarian nominated by the Stallion Owner/Agent.

3. REGISTRATION

The Mare Owner shall be responsible for the preparation of any documentation to the relevant Breeding Society. Breeding Certificates for AQHA, ASHS, PHAA will not be issued unless the above mentioned mares are registered with the breeding society at the time of signing this contract. If a late Stallion Breeding return is required, The Mare Owner is liable to pay the late fee required by the association. Non-registered mares are able to be bred.

4. RETURNING MARE

The Free Return is only applicable for the following season, on the condition that payment of the original service fee was made in accordance with this contract. If the Mare Owner fails to deliver the mare for re-breeding in the following season, then the right to a Free Return is null and void, unless a private treaty is agreed upon by the Stallion Owner and the Mare Owner, which may only come into effect under extenuating circumstances.

Care and reasonable precautions will be taken; however, The Mare Owner understands that the Stallion Owner/Agent takes no responsibility for injury, accident, sickness, death, or disease to the Mare or Progeny.
