1. The breeding **Service Fee** (\$2500 +GST) will be paid in full on return of said breeding contract. Agistment and veterinary expenses will be paid in **FULL** on mare departing Wilmor Downs.
2. Mares bred to **WILLINGA SNOWY** at Wilmor Downs Equine Breeding Services, will **NOT** incur a collection or AI fee, this cost is included in the service fee. Breeding drugs, vet fees, scans and agistment is extra. Vet fees and service fee must be paid on mare's departure from Wilmor Downs.
3. Off farm mares requiring chilled semen, the **FIRST** collection fee (\$300) is included in the service fee. Shipping is extra and to be paid before chilled semen is sent. Quote on shipping will be supplied. If a non pregnancy results from the first breeding, a **collection and shipping** fee will apply for the subsequent collections required.
4. If shipped / chilled semen is needed, *24 hours notice is required*. A Semen Collection Form must be filled out and the shipping fees must be paid before semen will be shipped. Wilmor Downs shall not be held liable for contamination or damage of semen during or after shipment, loss of viability or any costs arising from shipments delayed, damaged or lost in transit. Wilmor Downs guarantee to ship the **highest quality** semen, however will make no guarantees or warranties on delivered semen.
5. The mare owner warrants that to their knowledge the mare being breed to WILLINGA SNOWY and arriving at Wilmor Downs, will be in good health and has NOT been in contact with CONTAGIOUS EQUINE METRITIS, STRANGLES OR ANY OTHER INFECTIOUS DISEASES. A vet pre breeding scan is suggested before breeding your mare. Mares **must** be **dewormed** and up to date with **tetanus / strangles vaccinations** before arriving at Wilmor Downs.
6. All veterinary expenses including scans and any treatment the mare requires while at Wilmor Downs will be at the mare owners expense. It is agreed that Wilmor Downs shall not be responsible for any injury to the Mare or her progeny or loss incurred by the Mare Owner however caused. Nor shall they be responsible for any disease, accident, sickness or death to the Mare or foal.
7. Agistment for dry mares \$20 per day, wet mares \$30 per day. If mare requires private paddock agistment with hay and hard feed twice daily \$40 per day. Agistment will be charged from the day of mares arrival to Wilmor Downs until the date of departure.
8. A **Live Foal Guarantee** is offered with this service fee if the foal dies within 48 hours of foaling, or if stillborn, in both cases a report certified by a practicing Veterinary Surgeon is required within 10 days of the date of the foal's death. It is then agreed that the Owner may return the Mare for breeding for the following breeding season and no additional Service Fee will be charged, for one season only, other associated charges will still apply.
9. A **Filly Foal Guarantee** is offered, with the mare stated in this breeding contract, for her first breeding to Willinga Snowy. It is agreed that the owner may return the mare for the following breeding season and no additional Service Fee will be charged if a colt foal is the result of the mares first breeding. Valid for the next breeding season only, other associated charges will still apply.

10. AQHA Breeding Returns will only be submitted if the above mare mentioned, is registered with the AQHA at the time of signing this breeding contract. If a late stallion breeding return is required, the mare owner is liable to pay the late or extra fees required. ASH breeding certificates will only be available on request, if the above mare mentioned is ASH registered and after the resulting progeny is born.
11. When the Mare Owner signs and returns this contract to the Stallion Owner it will be a binding contract for both parties' subject to the above terms and conditions. This contract is not transferable or assignable. In the event that the said mare is sold, the Service Fee and any other outstanding fees, shall immediately become due and payable by the undersigned owner. The Service fee is not transferable.
12. It is further agreed that should the Stallion die or become unfit for service, or the above named Mare should die or become unfit for service, then this contract shall become null and void. Agistment and Veterinary Fees must be paid by the mare owner where required.
